

Compliance Program for Business Partners

Purpose and scope, relationship to other documents

- This document sets out the requirements of R.F.PROFI s.r.o. (Company ID: 25952536) towards its business partners, in particular suppliers and customers, regarding compliance with legal regulations, ethical rules, and principles of fair business conduct. Compliance with legal regulations

- We expect our business partners to notify us if they or their partners related to our business
 relationship are included on any sanctions list and/or that our business relationships with them
 are in conflict with such lists.

Ethical conduct

- We expect our business partners to act honestly, transparently, and in accordance with generally accepted ethical standards.
- No form of corruption or bribery is tolerated.

Competition and unfair competition

- Cartel agreements, price fixing and market sharing agreements are prohibited.
- Unfair competition, misleading advertising, free riding on reputation and other practices that distort fair competition are prohibited.
- Any form of manipulation in public tenders is prohibited.

Conflict of interest

• We expect our partners to actively prevent conflicts of interest.

Environmental protection

• Our partners are obliged to minimize the impact of their activities on the environment and comply with relevant environmental standards.

Information protection

• We bind our partners to protect sensitive information, trade secrets, and personal data in accordance with the GDPR.

- Notifications shall be sent to the Compliance Officer's email address.
- The Compliance Officer is obliged to document such notifications and resolve them with the company's management, and to document the manner in which they were resolved.
